#### Inaugural ICFHS Ian Webster Oration



The Inaugural Ian Webster Oration of the International Centre for Future Health Systems (ICFHS) was held at the University of New South Wales (UNSW) Health Translation Hub building on 25<sup>th</sup> November 2025. The orator was Associate Professor Shannon Nott, a distinguished Australian rural doctor, working as an anaesthetist, retrieval physician, and clinical services executive, and as the Chief Medical Officer and Executive General Manager of Health and Clinical Services at the Royal Flying Doctor Service. The oration was titled "Heroes of Australian Health Care: What the future holds for the Royal Flying Doctor Service", and described the history of the Royal Flying Doctors Service and the important role it continues to play in delivering health care in Australian rural and remote areas, where health infrastructure on the ground is minimal. She was previously a Senior Research Fellow at the George Institute for Global Health. ### **MedConnect | The hospital of the future**



The International Centre for Future Health Systems was delighted to welcome over 1500 registrants to our second MedConnect event in partnership with the Faculty of Medicine & Health at the University of New South Wales, and in collaboration with the NSW Ministry of Health. For decades healthcare has focussed on the hospital, but this approach is not fit for a future where demographic and health problems will challenge traditional models. The conversation centered on what tomorrow's hospitals will look like. The need to move from traditional, centralised, bricks and mortar models to person-centred, technology-enabled systems was identified. Key messages from the panel included focusing on value-based health care, digitally enabled health solutions, and meeting individuals and communities where they are in the community. [Read more](#).

### **How societies can better support healthy ageing in the 21st century**



The International Centre for Future Health Systems (ICFHS), in collaboration with the Centre of Excellence in Population Ageing Research (CEPAR), recently co-hosted an event exploring how societies can better support healthy ageing in the 21st century. A keynote address by Professor John Beard, from Columbia University, emphasised the importance of the World Health Organization's Healthy Ageing Framework, which centres on an individual's ability to do and be what they value. Professor Beard called for a fundamental shift from disease-based models of care toward a focus on intrinsic capacity and functional ability, arguing that this reframing has the potential to transform how ageing is understood and supported globally. He suggested that Australia could learn from the example of France, which is an early adopter in embedding the healthy ageing framework into national health system reform including via comprehensive capacity assessments in primary care. ### **Shaping the Future of Australian Primary Health Care: launch of new national research collaboration**



The Inaugural Strategic Think Tank for the new MRFF funded National Multidisciplinary Primary Care Research, Policy and Advocacy Consortium, was held in Geelong, following Australasian Association for Academic Primary Care (AAAPC) Conference. Organised by the Consortium Coordinating Team at UNSW, the event brought together members from across Australia for a collaborative day focused on shaping the future of multidisciplinary team based (MDT) primary health care. The Consortium includes 100 of Australia's leading primary care researchers, including five researchers from ICFHS: Professor Michael Kidd AO, Associate Professor Margo Barr, Associate Professor Freddy Sitas, Associate Professor Michael Wright and Dr Peri O'Shea. ### **ICFHS Associate Professor Margo Barr awarded funding to develop an early detection AI tool**



ICFHS researcher Associate Professor Margo Barr has received \$1.3 million in funding through the Medical Research Future Fund's (MRFF) *Improving Health Outcomes for People with Intellectual Disability* scheme to lead the development of EarlyCare AI, a generative AI tool to help people with intellectual disability and their caregivers detect health concerns earlier and manage them more effectively. The project will be co-designed and tested with people with intellectual disability and their supporters. [Read more](#).

The International Centre for Future Health Systems (ICFHS) and Murrumbidgee Local Health District (MLHD) have announced the four recipients of their inaugural joint research fellowships. The fellowships were presented by Dr Barbara Taylor, Director of Research at MLHD, Associate Professor Margo Barr from ICFHS, and Emeritus Professor Mark Harris. These fellowships, introduced for the first time in 2025, aim to strengthen research capacity within MLHD and are the outcome of more than two years of collaborative efforts between ICFHS and MLHD. The 12-month fellowships will provide each recipient with mentoring and guidance from experienced researchers and experts in their respective research fields. ### **ICFHS research on the features of primary care patient enrolment schemes around the world**



A research team, led by the International Centre for Future Health Systems (ICFHS) Senior Research Fellow Dr Shona Bates, with colleagues Associate Professor Michael Wright, Dr Peter Brown, Dr Rafal Chomik, Dr Jialing Lin, Professor Michael Kidd AO, and international colleagues Dr Tara Kiran (University of Toronto) and Dr Luke Allen (University of Oxford), undertook work to build our understanding of patient enrolment policies in primary care. ### **ICFHS research on the use of multi-disciplinary teams in primary care around the world**



A research team, led by the ICFHS Senior Research Fellow Dr Shona Bates, with colleagues Dr Jialing Lin, Associate Professor Michael Wright, Professor Michael Kidd AO, and Dr Luke Allen from the University of Oxford, undertook a scoping review to build our understanding of the use of multi-disciplinary teams in primary care. This work was prompted by the recommendations of the Strengthening Medicare Taskforce Report that included encouraging team-based multidisciplinary care based on the assumption that multi-disciplinary team care improves the quality of primary care. ### **A new guide to designing, reporting and appraising studies of AI Chatbots**



Generative AI chatbots (e.g. ChatGPT) are increasingly used in healthcare but many of the studies evaluating them are poorly done. ICFHS Associate Member Dr Anthony Sunjaya as part of the CHART Collaborative of global AI researchers has developed and published a new reporting tool for studies evaluating healthcare advice provided by chatbots (e.g. ChatGPT, Gemini, Copilot, Claude, DeepSeek). #### **ICFHS researcher, Dr Jialing Lin, writes in The Conversation about shingles vaccination uptake during the COVID-19 pandemic**



Dr Jialing Lin has written for The Conversation about how shingles vaccination rates changed in the United States of America before and during the COVID-19 pandemic. As the most effective way to prevent shingles and its complications, the vaccination rate rose during the COVID-19 pandemic, and the rates rose more quickly among some underserved groups, such as those from racial and ethnic minority groups and those with low household income. #### **E-cigarettes are likely to cause lung cancer and oral cancer**



A report by the Clinical Oncology Society of Australia (COSA) Working Group on "E-cigarettes and Cancer – a qualitative assessment", which included Professor Bernard Stewart (UNSW, Chair) and ICFHS Adjunct Associate Professor Freddy Sitas was published on 5 August 2025. After reviewing the existing laboratory, animal and human evidence, the Working Group concluded that nicotine-based e-cigarettes contain known carcinogens, "Nicotine-based e-cigarettes are likely to be carcinogenic to humans who use them, and 'E-cigarettes are likely to cause lung cancer and oral cancer'. This finding is a call for good epidemiological data to provide quantitative assessments on the level of risk. [Read more.](#)

#### **ICFHS student highlights new findings for people with Parkinson's in Latin America**



ICFHS higher education student Christine Jeyachandran has published the first qualitative study capturing the perspectives of people with Parkinson's across Latin America. The study identifies stigma, limited services, and a lack of symptom recognition by health professionals as major barriers to care, and calls for global collaboration to improve health outcomes, training of health professionals, and the co-design of a resource kit to support people with Parkinson's and their families. Christine has been supervised by ICFHS Emeritus Professor Mark Harris and researcher Dr Catherine Spooner. [Read more.](#)
