





# COMMUNITY CONSULTATIONS USING RECIPROCAL RESEARCH: Session 5: The Matrix Exercise



The Matrix exercise helps to explore ways that different groups in the community are affected by different issues. It focuses around discussion of each section of a complex matrix of issues of concern to the community.



It is a method that facilitates an in-depth exploration of some of the issues identified in the discussion on human rights or in the stories shared by participants. It builds a more detailed picture of how different groups in the community experience human rights, and what the main issues of concern to the



The matrix is a table of different 'issues of concern' or human rights (shown on the left side of the matrix), along with different categories of people in the community (shown along the top of the matrix).

In small groups, participants discuss the different ways that each issue of concern impacts on each category of people. They write their responses on 'post it' notes, one for each issue they want to put in box in the matrix.



Each small group presents the points they have discussed to the rest of the participants, adding their sticky notes to the correct box on the matrix.

There are often many issues for each box.







### **Matrix Group Exercise**

Divide participants into small groups, and depending on time, ask them to work with all categories, or two or three sections of the matrix, ensuring that all sections are covered. to work on.

Their task is to identify the particular barriers faced by each different group of women and girls along the top, to the human rights on the left hand side



#### **Documentation**

Have one or two people carefully documenting what participants say as they post their notes onto the matrix.

This is an important part of your evidence about what is happening in any particular site.
