Message from the ICFHS Director

Welcome to the first newsletter of the International Centre for Future Health Systems (ICFHS), based at the University of New South Wales (UNSW). We are planning to share this newsletter four times a year, providing you with updates on our policy work, our projects, our publications, and our advocacy, as well as the individual achievements of ICFHS members.

The ICFHS is a research, policy and advocacy initiative, formally established by UNSW on 2 August 2024. Initial financial support, for a period of five years, has been provided by the Ian Potter Foundation and UNSW.

The ICFHS is a pan-university centre, with jointly funded post-doctoral research appointments with each of the Faculties of UNSW: Arts, Design and Architecture; Business; Engineering; Law and Justice; Medicine & Health; and Science. I am pleased to advise that all these positions have been filled and the full research team will be working with us from mid-February.

A major boost for the centre was the incorporation in September of the staff and projects of the internationally-renowned UNSW Centre for Primary Health Care and Equity. Primary care and health equity are fundamental pillars of health systems and I welcome this initiative by the university which will allow our new centre to grow and become highly productive much earlier than originally anticipated.

Our partnership with the University of Oxford has also been strengthened by the recent appointment there of Senior Researcher, Adjunct Associate Professor Luke Allen, recruited from the London School of Hygiene and Tropical Medicine.

Among the highlights of the past year were our policy and research forums with Australia's Ambassador for Global Health, Adjunct Professor Lucas de Toca PSM, and with colleagues from the Australian Government Department of Health and Aged Care, as well as our co-hosting of the UNSW MedConnect Future Health Workforce event, featuring NSW Chief Health Officer, Dr Kerry Chant AO PSM (see more details below).

As the new year begins, I hope you have had a happy and enjoyable holiday season, and that you were able to spend time with your loved ones, as well as re-energising in preparation for the year ahead.

I look forward to working with you in 2025 as we lead research, policy and advocacy work on health systems reform at local, national and global levels.


ICFHS Director interviewed on a podcast on 'UNSW and the Future of Australian Health Care'
